Applicants should go to the Academy of Nutrition and Dietetics to receive instructions and timelines for computer matching and information on the Dietetic Internship Centralized Application Services (DICAS). There is a \$55.00 D & D computer matching fee, a \$30.00 NHC application fee, a \$50.00 DICAS fee and a \$50.00 graduate school application fee (only if matched with NHC).

I am pleased that you are interested in our program. In the next few months, you will have to make many important decisions. With the NHC DI/MPS program, you have options to not only continue your education but also begin a promising career. Potential applicants are welcome to contact the program director to schedule in person or virtual visits to the program. To become a registered dietitian (RD) or registered dietitian nutritionist (RDN) an individual must complete a process as outlined (and listed below) on the Academy website:

- **Completed a minimum of a bachelor's degree** at a US regionally accredited university or college and course work accredited by the Accreditation Council for Education in Nutrition and Dietetics of the Academy of Nutrition and Dietetics.
 - *Effective January 1, 2024, the Commission on Dietetic Registration, the organization that administers the exam, will require a minimum of a master's degree to be eligible to take the exam. More information is available on the [CDR website](#).*
- **Completed an ACEND®-accredited supervised practice program** at a health-care facility, community agency, or a foodservice corporation or combined with undergraduate or graduate studies. Typically, a practice program will run six to 12 months in length.
- **Passed a national examination** administered by CDR. For more information regarding the examination, refer to [CDR's website](#).
- **Completed continuing professional educational requirements** to maintain registration.

The primary objective of the program is to train qualified individuals to become competent dietitians. For the 2022-23 class, six dietetic interns were selected for the program. For the six interns matched in the spring of 2023, the combined DI/MPS program will be a 15-month internship program beginning in early June 2023 and ending the following summer in August 2024. Currently, dietetic interns rotate through the following facilities: NHC centers in the Middle Tennessee area, Skyline Medical Center, Horizon Medical Center, VA TN Valley Healthcare System, Fresenius Kidney Care, school foodservice, wellness and fitness experiences and various locations in Memphis for pediatric training. In addition, interns will complete an online 30-credit hrs. in the MPS graduate program.

Care is taken during recruitment and selection, as well as actual administration, to protect student civil rights. The program director seeks a diversified class and works to maintain an appropriate percentage between minorities who interview for the program and those accepted. The program and sponsoring

organization both adhere to policies regarding the selection, hiring and promotion based on ability regardless of race, color, religion, creed, sex (including pregnancy, gender identity and sexual orientation), age, national origin, disability, and genetic information. Student privacy is respected during the program. Grades and evaluation outcomes are handled on an individual basis, and space is provided in the internship director's office for private counseling as needed.

ACCREDITATION

The NHC Dietetic Internship Program is currently granted accreditation status by ACEND of the Academy of Nutrition and Dietetics, 120 South Riverside Plaza, Suite 2190, Chicago, IL 60606-6995, 800-877-1600, Ext. 5400. NHC MISSION, GOALS, AND OBJECTIVES

Specific outcome levels achieved for these objectives are available from the director upon request.

The mission of the NHC's Combined DI/MPS program is "To prepare interns to become successful entry-level registered dietitian nutritionists through supervised practice and didactic learning experiences in clinical, foodservice management and community nutrition with an emphasis in geriatric nutrition, as well as leadership in nutrition. "The mission of the program drives the goals and outcome measures that are listed below:

The specific program goals and objectives to meet these goals are listed below:

Goals and Objectives:

Program Goal 1: The program will produce competent graduates who are prepared for entry-level practice as registered dietitian nutritionists.

Objective 1.1: At least 80% of program interns complete program/degree requirements within 150% of the planned program length.

Objective 1.2: Of graduates who seek employment, at least 83% are employed in nutrition and dietetics or related fields within 12 months of graduation.

Objective 1.3: At least 83% of program graduates take the CDR credentialing exam for dietitian nutritionists within 12 months of program completion.

Objective 1.4: The program's one-year pass rate (graduates who pass the registration exam within one year of first attempt) on the CDR credentialing exam for dietitian nutritionists is at least 80%.

Objective 1.5: Program graduates will rate knowledge and preparedness for entry-level dietetics practice as adequate, as evidenced by a mean score of 4.0 or higher (out of 5.0) on the graduate/employer survey.

Objective 1.6: Employers of program graduates will rate knowledge and preparedness for entry-level dietetics practice as adequate, as evidenced by a mean score of 4.0 or higher (out of 5.0) on the graduate/employer survey.

Program Goal 2: The program will prepare graduates to practice in the geriatric nutrition field and provide a return on investment (ROI) for the sponsoring institution.

Objective 2.1: Over a five-year period, 40% of graduates provide the sponsoring institution with one to two years of work, to provide a return on investment (ROI) to NHC and encourage further sponsorship of the program.

Program Goal 3: The program will prepare graduates to demonstrate a commitment to the community through professional involvement, leadership and service in a variety of personal or professional settings and demonstrate a commitment to lifelong learning.

Objective 3.1: When surveyed, graduates will rate their level of involvement in professional activities, community service or leadership activities as adequate, as evidenced by a mean score of 4.0 out of 5.0 or above on the graduate/employer survey.

Objective 3.2: Dietetic interns will write a personal action plan identifying personal and professional competency. At the end of the program, each intern will have met 66-75% of these competencies.

Objective 3.3: Dietetic interns will demonstrate how to complete a sample CDR professional development portfolio (PDP) plan.

Objective 3.4: When surveyed, graduates will rate their participation in continuing education activities as adequate, evidenced by a mean score of 4.0 out of 5.0 or above on the graduate/employer survey.

CURRICULUM, SCHEDULE, AND PROGRAM COMPLETION

The 15-month program currently provides approximately 1050 supervised practice hours (August 2023-May 2024) as follows:

The NHC Dietetic Internship is completed in approximately 15-months on a full-time schedule beginning in early June and extending into mid-August of the following year. Most weeks consist of at least 40 hours per week of classes and supervised practice experiences, with completion of written projects being done at home. A two-week orientation is mandatory for all interns held at NHC corporate office in Murfreesboro, TN. Before starting the program, interns must have proof of medical insurance, have professional liability insurance (paid for by NHC), drug screen (paid up to \$50 by NHC), background check (completed and paid for by NHC), and health form requirement. Currently, the supervised practice hours are completed Tuesdays through Fridays except for approximately two weekends. If a leave of absence is requested and approved by the director, the program requirements must be completed within 150% of the program length or 23 months. Information regarding leave of absences will be discussed further in the policy and procedure manual upon acceptance into the dietetic internship. A master rotation schedule is given to each student at the beginning of the program and monthly Monday class schedules are given to interns at least two weeks ahead of time.

Both didactic and supervised practice experiences shall be included in the dietetic internship program. Planned learning experiences shall be offered in logical progression from introductory to the expected degree of competence in program graduates. RD Exam practice tests will be administered throughout the year and will require a passing score to graduate from the program. In addition, during the final week of the supervised practice portion of the program, the interns will complete procedures for eligibility to take the RD examination. The RDE misuse form will be explained by the director and signed by students to be kept in their student files.

Upon graduation, students are expected to have met core and emphasis competencies and all graduate courses with the required grades. Successful completion of all didactic training, 1000+ supervised practice hours, rotation assignments and graduate coursework, will ensure that the core competencies for entry-level dietetics, and geriatric emphasis competencies, have been met and that a verification statement will be issued to graduates. Grading expectations are listed in the policy and procedure manual.

MEMPHIS TRAINING

One week of pediatric training will be scheduled in the spring in Memphis, Tennessee, depending on Covid-19 and travel safety. When traveling to Memphis, housing has traditionally been provided by

NHC. Some meals and gas are reimbursed by NHC. The projected cost to the intern for the Memphis rotation is approximately \$100.



STAFF RELIEF

Staff relief is scheduled at an approved NHC facility in a convenient location for minimal lodging and/or travel costs to the intern.

COMPLAINT POLICY

Any grievances or complaints about the dietetic internship should first be presented to the director. If the intern is dissatisfied with the results of the conference with the director, then the intern should make a request, in writing, for a conference with the grievance committee. The Grievance Committee will be composed of at least two (2) dietitians of NHC, the director, and a staff member of the home office of NHC. If the intern is still dissatisfied, then a written request should be made for a conference with the senior vice president of patient services. All grievances will be documented and signed by the director and the intern. The original will be filed in the intern's folder and kept on file in the office of the director.

If the intern has a grievance or complaint related to their graduate courses at MTSU, they will be encouraged to discuss it with their MTSU professor first, then their MTSU advisor. If that does not resolve the issue, they will be encouraged to discuss it with the DI Director who will help direct them to the proper MTSU contact.

If an individual other than an intern such as faculty, preceptor, dietetics practitioner and/or member of the public has a complaint, they may submit a complaint against the program. If the complaint can be addressed with the program director, that is the first course of action. If it is believed that it can't be resolved through the program director, the complaint can be brought to the senior vice-president of patient services. The procedure to file complaints against accredited programs to ACEND is discussed in the policy and procedure manual. Please submit complaints directly to ACEND only after all other options with the program and the institution have been exhausted. All grievances will be handled in a manner that prevents retaliation.

CLASSES

Interns will meet once a month on Mondays for dietetic internship classes on various topics throughout the entire program. Interns will complete their online MPS graduate coursework on evenings, weekends and Mondays.

BENEFITS AND EXPENSES

STIPEND

A stipend of \$1,350.00 (total for the year) during the supervised practice portion of the program is provided by NHC. The first check will be mailed in September 2023 and the final check in May 2024. Monthly checks will be mailed on the first Friday of the month.

INSURANCE

Interns are **REQUIRED** to obtain their own health insurance and professional liability insurance while completing the NHC DI program. Interns provide proof prior to beginning the internship. The cost of the liability insurance premium will be reimbursed once the intern starts the program. Interns are responsible for all medical expenses incurred during the internship, including having a physical exam, all required vaccinations, and a drug screen prior to starting the program.



The Covid-19 vaccination policy is discussed in Step Two of the application process further down in this document. A background check will be conducted and paid for by NHC. Interns are required to have automobile insurance and assume own liability while traveling to and from internship practice experiences and classes.

MTSU TUITION – MPS GRADUATE DEGREE

Graduate school tuition and fees (textbooks not included) are listed below. In-state students pay in-state tuition and fees, and out-of-state students pay the e-rate in the two summer semesters when they are not on their supervised practice rotations and in-state tuition during the spring and fall semesters while they are in middle TN for their supervised practice rotations. There is no tuition for the NHC supervised practice portion of the DI. Fee schedules will be updated for 2023-24 so please check the MTSU website for updated fees. Projected fees for the 2022-23 sessions should be approximately:

MEALS

During assigned training only, lunch will be provided on most rotations. Interns will be responsible for meals on class day and when attending meetings.

FNCE OR OTHER NATIONAL MEETING

Attendance is required at a national meeting either in person or virtually. The dates and location will be discussed upon acceptance into the program. If FNCE is approved to be attended in person, registration and hotel (if needed) are paid by NHC. Interns are responsible for paying for their travel (gas or airfare) and meals while at the meeting.

HOLIDAYS/VACATIONS

Interns are permitted a two-week vacation during late December and early January. The holidays for the year will be Labor Day, Thanksgiving (2 days), Christmas Day and New Year's Day. The vacation dates for 2023-2024 will be during late December and early January.

HOUSING

Interns will be responsible for all housing costs during all training, except the weeks of FNCE and Memphis. Numerous apartment complexes are available in Murfreesboro and Nashville. Monthly rental for one- or two-bedroom apartments is approximately \$1000 to \$2000 per month, depending on location and roommate availability.

SUPPLIES

Some supplies for special projects are reimbursed. Supplies purchased must have a receipt and be turned in on the proper form to the internship director. This does not include routine daily supplies, e.g., paper, pencils and pens, which are the responsibility of the intern. Some textbooks are provided for the dietetic intern but are to be returned upon program completion. Interns will be responsible for paying for scrubs and lab coats in the amount of approximately \$100.00. NHC will provide the interns with NHC embroidered polo shirts which can be worn on most rotations if desired. All copying should be done at NHC's corporate office if possible. The cost of the textbooks and supplies for the graduate courses will be the intern's responsibility.

TRANSPORTATION

Interns must have access to a vehicle at all times. All maintenance and mileage expenditures will be the responsibility of the intern. Facilities are in the Murfreesboro, Nashville and surrounding middle TN area except for the Memphis pediatric rotation. A gas allowance is given for some rotations. Monthly transportation costs can range from \$200-\$500 depending on where you live and gasoline prices.

FINANCIAL AID

Interns may apply for NHC dietetic internship tuition reimbursement scholarships of \$1,000 each to assist in the payment of education expenses during the dietetic internship. Tuition reimbursement scholarships are awarded to applicants demonstrating professional potential in long-term care and require a work obligation of one year after graduation. Interns who choose to work for NHC will also receive a \$2,000 recruitment bonus at graduation. Tuition reimbursement scholarships and recruitment bonus are available to graduates accepting employment with NHC up to one year after graduation.

MTSU Graduate School Financial Aid: Once you have matched to NHC and applied to the MTSU graduate program, you may complete a Free Application for Federal Student Aide (FAFSA). A FAFSA may be submitted before your MTSU admission decision. POLICY ON GRANTING CREDIT FOR PRIOR LEARNING EXPERIENCE

Graduates of ACEND-accredited didactic programs who have held post-graduate (unless otherwise approved) paid positions in the field of dietetics with responsibilities that fulfilled certain ACEND competencies may be granted credit for prior learning. In addition, applicants with a completed graduate degree may also receive credit for prior learning and all or a portion of the required graduate coursework may be replaced. It will be determined by the program director if the experience will replace a portion of a rotation or course or if an alternate rotation will be provided to provide time to focus on a special interest of the intern.

The process must be initiated prior to beginning the internship to accommodate changes in scheduling. The process for establishing credit for prior learning is as follows: 1. Intern will contact director after internship appointment between April and June to request an assessment of prior learning. If the request to assess adequacy of prior learning is verbally approved, then the intern will follow up with a written request describing in detail the prior learning experience. 2. Intern will provide contact information to verify prior learning experiences. 3. Program director will determine if prior credit replaces a portion of a rotation or course or if an alternate rotation will be provided for the intern. 4. Intern will provide official transcripts of previously completed graduate degree, if applicable.

APPLICATION FOR NUTRITION AND DIETETICS SCHOLARSHIPS FOR 2023-2024 ACADEMIC YEAR

The application can be downloaded from the Academy of Nutrition and Dietetics from September 2022 to February 2023. Traditionally, the scholarship application must be completed and postmarked by February 15, 2023, but please check the website for updated deadlines.

APPLICATION & ADMISSION

The Dietetic Internship Program at NHC is participating in the centralized application process. There are four steps to the application process:

Step One: DICAS online application

Step Two: NHC Supplemental Application Form

Step Three: D & D Digital Computer Matching

Step Four: Apply to MTSU MPS Program (the last week of April, immediately following matching and accepting NHC's program)



STEP ONE: CENTRALIZED APPLICATION: DICAS

- ◆ DICAS Application can be accessed at Dietetic Internship Centralized Services (available after 11/1/22)
- ◆ Email DICASinfo@DICAS.org. The online application MUST be completed by February 15, 2023 at 11:59 pm, Central Standard Time. Confirm this deadline on the DICAS website.
- ◆ The fee to DICAS is \$50.00 for the first application and \$25.00 for each additional application.
- ◆ On the DICAS application, applicants will be asked to complete a personal statement in 1,000 words or less. NHC appreciates personal statements that are less than 500 words. Information to be addressed includes:
 1. Why do you want to become a dietitian?
 2. What are some experiences that have helped you prepare for your career?
 3. Short and long-term goals.
 4. Strengths and areas needing improvement.
 5. Why are you applying for the NHC program?
- ◆ Official transcripts from all colleges and universities attended should be sent to:

- ◆ GRE score is not required with an undergraduate gpa of 3.25 or higher. There are also exceptions for graduates with lower gpa's who have prior professional work experience in a related field. Please review the MPS graduate degree webpage for admission requirements at <https://www.mtsu.edu/university-college/mps/> If you do take the GRE and want to include it, please send documentation of the GRE score to MTSU and with NHC's Supplemental Application.

- ◆ The recommended minimum GPA is 3.0 (overall) and 3.2 (DPD). The average GPA over the past three years has been 3.6 to 3.8.
- ◆ When completing the application form, you must list three references and include the names and contact information (email address) for each. This will trigger an email message requesting completion of a reference form. The form will be completed online. At least one recommendation from your advisor or a professor in your major field and a work recommendation are preferred.
- ◆ Work experience, especially in a nutrition or food service-related field, is recommended. Leadership roles, length of employment, number of hours worked, and volunteer experience will also be considered.
- ◆ Over the past five years, we have received approximately 25-30 applications per year. Once these applications are reviewed, approximately 15-18 are selected for a virtual interview.
- ◆ Regarding the Covid-19 vaccination series, some of the affiliate sites where the dietetic interns complete supervised practice hours are under vaccine mandates and some of them do not accept religious or medical exemptions currently for students. With this consideration in mind, the 2023-24 NHC dietetic internship matched applicants will be required to be fully vaccinated to begin the program in June 2023. Please do not include this information in your application or during an interview if you are selected for an interview. If you are matched with NHC and accept your position for the 2022-23 year, you will be required to show documented individual proof of current full vaccination by May 15, 2023. At this time, it is uncertain whether boosters will be required or not for students in health care.
